




HOW TO PROVIDE COMMENTS DURING A SCOPING MEETING

CHANGING YOUR ZOOM LAYOUT






In the upper right corner of your window, you should see a symbol that looks something like one of these.

Clicking through these will change the layout of your screen and allow you to do things like maximize the presentation size or display everyone's video in a gallery format.





Metro Transit Expansion

Buffalo-Amherst-Tonawanda Corridor Transit Expansion

- Transit expansion project to continue high frequency and reliable service into Tonawanda and Amherst
- The transit expansion would be approximately 7 miles with 10 stations and 2 park-n-rides
- A goal of the project is to improve job access
- The project would improve sustainability and reliability




METRO RAIL HISTORY

NFTA initiates Transit Options Amherst-**Buffalo Alternatives** Analysis (AA) for Amherst corridor

NFTA completes 3-tier screening evaluation to identify Locally Preferred Alternative Light rail ranks highest

NFTA designated as Lead Agency to conduct an environmental review process under the State **Environmental Quality** Review Act (SEQR)

FTA designated as Lead Agency to conduct environmental review under the National Environmental Policy Act (NEPA)



NFTA proposes a

43 mile network of rapid transit rail lines, including a 14 mile line from Downtown Buffalo to Amherst

2016

GBNRTC initiates comprehensive Transit-Oriented Development (TOD) study to support AA 2018

Locally Preferred Alternative (LPA) is refined, based on stakeholder input

2020

NFTA releases SEQR Draft **Environmental Impact** Statement (EIS) and initiates public comment period, including public hearings



What's Changed

Building upon previous technical work and public outreach:

- Federal Transit Administration (FTA) will be Lead Agency with NFTA as Co-Lead Agency
- Utilizing the State Environmental Quality Review Act (SEQR) DEIS, a National Environmental Policy Act (NEPA) EIS will be prepared
- An additional Build Alternative will be considered in the EIS:
 - Bus Rapid Transit (BRT), along with
 - Light Rail Transit (LRT)



What is Scoping?

Scoping is an early and open process for determining the scope of issues to be addressed and for identifying the significant issues related to a proposed action

Environmental Review Process

- Prepare a NEPA EIS
- Assess potential effects of the build alternative(s) and develop mitigation measures for adverse effects
- Provide meaningful opportunities for public participation during the environmental process



Purpose and Need

- The purpose of the Buffalo-Amherst-Tonawanda Corridor Transit Expansion project (Proposed Action) is to link established and emerging activity centers along the existing Metro Rail line in Buffalo with existing and emerging activity centers in Amherst and Tonawanda to provide a fast, reliable, safe, and convenient transit ride. Additionally, the Project would improve livability by increasing mobility and accessibility in communities throughout the region.
- The need for improved transit service has three main components:



Serve existing and future travel demand



Provide high-quality regional transit service



Improve service for transit-dependent population

LRT Build Alternative

- Approximately 7-mile LRT extension from UB South University Station to I-990 / Audubon Parkway
- •0.8 mile tunnel on southern segment
- Operating in median of Niagara Falls Boulevard from:
 - Kenilworth Avenue to Maple Road
- Operating in median of Maple Road from:
 - Alberta Drive to Sweet Home Road
- Operate under intersection of Maple Road / Sweet Home Road
- Operating on east side of Sweet Home Road from:
 - Maple Road to Rensch Road
- •Operating within UB North Campus
- •Operating along Audubon Parkway to re-use the Parkway's northbound footprint
- •10 Stations
- •2 Park-and-Rides
- •1 Overnight Storage Facility




BRT Build Alternative

- •Approximately 7-mile BRT system from UB South University Station to I-990 / Audubon Parkway
- •Operating in Mixed Traffic from UB South Campus, along Main Street and Kenmore Avenue
- •Operating along same footprint as LRT from Kenilworth/Niagara Falls Boulevard to I-990/Audubon Parkway
- Surface running along entire alignment
- •10 Stations
- •2 Park-and-Rides
- •1 Overnight Storage Facility
